Publications I was involved in data collection for a study which evaluated a screening tool which had been developed to detect Autism Spectrum Disorder in the Scottish prison population. This study led to the publication of a paper in May 2012 on *'Evaluation of a Screening Instrument for Autism Spectrum Disorders in Prisoners'*.

> June 2011- 'Admission Characteristics of Patients with Learning Disability Admitted to The State Hospital over 20 years (1988-2007)' This retrospective and descriptive study described the demographic, psychiatric and criminogenic characteristics of people with a Learning Disability admitted to the State Hospital over a 20 year period and aimed to identify any change in admission trends over the two decades. This study provided an interesting insight into how significant developments in the methods of diagnosing patients with learning disabilities coupled with the expansion of medium, low and community forensic learning disability services in Scotland appeared to have influenced the typology of patients admitted in the latter half of the study period.

June 2009- Characteristics of Female Patients Admitted to Medium Secure Setting: An Eight-Year Study in Scotland's First Medium Secure Unit

This retrospective and descriptive study analysed the demographic, psychiatric and criminogenic characteristics of 42 female patients admitted to medium security over an 8 year period (Jan 2001-Jan 2009). The results favoured the idea of developing a national medium secure service than regional units for female offenders. Owing to the characteristics of the group (victims of sexual abuse and self-harming behaviour) the study strongly supported the idea of single sex wards.

I presented my findings as a poster and this won the Best Poster Award at the 9th Annual Conference of the International Association of Forensic Mental Health Services, Edinburgh, UK, in June 2009.
